Here is how the nominee is chosen:

- This award is presented annually to an organization or individual representing a conservation organization for their outstanding leadership in the development and implementation of conservation programs and activities that have directly benefited fish, wildlife, and/or native plants on public lands or their use, enjoyment, and appreciation.
- Nominees of this award must have demonstrated sustained dedication, leadership, and commitment to work collaboratively to build partnerships that promote sound land management practices and the conservation of wildlife, fisheries and/or native plant resources that depend on public lands. Nominee accomplishments can be at either a local, regional, or national level.
- Emphasis will be given to nominees who: have a long-standing partnership (four or more years) with the BLM and the Forest Service; have a demonstrated track record of cooperative conservation success; are recognized leaders in the conservation field; use unique or innovative approaches; and/or work to promote public understanding of cooperative conservation.
